# BUYER


You will receive a letter of confirmation from Green & Company with full details of the property and the vendor.

Next you must instruct a solicitor to handle all legal aspects of your sale including contracts, surveys, funds, searches, Land Registry and Stamp Duty.We can recommend a solicitor from our panel of local, approved firms. Your mortgage company will arrange a valuation survey on the property and you can choose to complete a property survey too. Your solicitor will also undertake various searches to determine any potential issues with the land and will request relevant certificates for any work that has been done to the property.

Once all matters are resolved, your solicitor will exchange contracts with the vendor's solicitor and a completion date will be agreed by the entire chain. This means that you are legally bound to purchase the property. Don't forget to book a removals firm if you need one and arrange house insurance for your new property.
